

Warm, cosy, and loving, our Dreamland room consists of 16 babies and 4 educators at a 1 to 4 ratio.

With their very own covered outside veranda and ageappropriate playground, our babies can explore and develop new skills in a safe and nurturing environment.

Barn yard fun with a view of our entire playground, our Farmland Room is made up of up of 25 children with 4 educators at a 1 to 5 ratio under 3yrs and 1 to 11 over 3yrs.

Jungleland 4 years - 5 years

29 Long Day Care with a Kindergarten program 9.00am to 3.00pm. 3 Educators always with our three highly qualified educators as well as an Early Childhood Teacher on board.

The Jungleland room also caters for our After-School Care Program for up to 5 to 6 children, 5

years – 12 years with the school bus coming directly from Cannonvale State school to our front door.

What an adventure our Jungleland holds! With its own built-in cubby house, our Jungleland room caters for a Kindergarten program enabling children to reach their full potential in school readiness.



The Jungleland room is headed up by 3 qualified Kindergarten Teachers, to encourage and engage all your child's independence and confidence.

Our Kindergarten children are enriched with the older children's presence, and for a school kid - what a way to expand your day after school, in a Jungleland Wilderness.

Days of Operation: We will operate Monday to Friday, closed for gazetted public

holidays, 52 weeks of the year.

Hours of Operation: 7.30am – 5.30pm daily

Child Care Subsidy (CCS)

Before discussing our fee plan, an explanation of Child Care Subsidy (CCS) is required. CCS is a Commonwealth Government initiative to subsidise the cost of quality Child Care. Services must meet strict regulations and auditing in order to receive CCS contributions on family's behalf.

Family's eligibility is subject to an income and activity test through Centrelink, and the results of the CCS application varies from family to family, therefore it is not within our scope to calculate your actual payment until after CCS payment has been allocated.

The important points relevant to our Terms and Conditions in relation to CCS and Fees payable by families are:

- ❖ Parents are responsible for ensuring that they have applied for CCS before their child starts at Jungle Zoo ELC. Please note, Centrelink will only backdate CCS payments, from the date of application. This may go to the family or Jungle Zoo.
- Claims for CCS subsidy payments are traditionally made to the Service, in arrears. Any backdated payment of CCS will be allocated to each family's account. Families are responsible for any payments that are not paid by Centrelink.
- Full fees are payable until CCS confirmation has been received by Jungle Zoo Early Learning Centre
- Child Care Subsidy is paid on booked hours.
- Signing in and out daily for each child is a mandatory requirement to receive CCS as well as assisting staff with emergency evacuations, roll call and other compliance requirements.
- Any changes to your family's situation must be determined and actioned by you in your relationship with Centrelink, as CCS is dependent on your family's relevant situation.
- ❖ Absentee days such as child is away due to illness, child is away on holidays, service is closed on a public holiday or where your child is not in attendance, but fees are charged, will be covered by CCS. Each child is eligible for payment of CCS for up to 42 absences per financial year. If your child's absences are close to this amount before the financial year ends, it is best to speak to Claire or admin for further information.

- * Reporting Absences: Jungle Zoo has a legal obligation to record all absences of children who are in receipt of government subsidy (CCS). If your child has been absent and you receive CCS, you have a legal requirement to notify our administration of the reason for each absence.
 - Notify admin or Claire if your child is going to be absent; and
 - State the reason why your child is absent e.g., illness, holidays.
 - Signing for your child's absence is mandatory and can be performed next time you are in via our kiosk system.

PLEASE NOTE: Part of family's obligations is to ensure via My Gov App, that once all paperwork has been entered by Jungle Zoo, that confirmation of enrolment is completed to ensure CCS is applied to your account. It is each Family's responsibility to maintain this account to ensure correct CCS payments can be claimed accurately.

Public Holidays

- Jungle Zoo will be closed on gazette Public Holidays³
- Fees are to be paid for Public Holidays if this would be your normal session of care.
- CCS will be available to subsidise your child's regular hours booked for any public holiday subject to family's applications. See our section on Child Care Subsidy.

Terms and Conditions

- ✓ Fees are required to be paid at least a full week in advance at all times. Families that nominate a payment frequency of weekly, fortnightly or monthly will be required to be a full week, fortnight or month in advance. Invoices/Statements will be supplied regularly through our OWNA portal, and printed and placed in family communication pockets internally.
- ✓ Fees are payable for all booked days whether the child attends Jungle Zoo or is absent.
- ✓ Jungle Zoo ELC is closed on all gazetted QLD public holidays. Fees are payable if your child's normal booked day falls on a gazetted public holiday.
- ✓ You must apply for Child Care Subsidy prior to your child starting at Jungle Zoo ELC.
- ✓ Until your application for CCS has been approved, full daily fees as per your child's weekly booked occupancy must be paid. When Centrelink has paid funding for your family, all CCS funds allocated for your child will be applied as a credit onto your account.

We will allocate .50 cents per child per day (booked and paid) fees to our Charity. Our goal of 10 children will be reached when we have a full capacity of childcare occupancy in our Service.

The Victor Chang Institute is developing amazing heart research and breakthroughs for children while in vitro to avoid heart issues and we are happy to support them with this work.

How to Pay your fees

Jungle Zoo will ensure that your statement of account is emailed to you on a regular basis and any enquiries or concerns regarding your account can be directed to Claire or admin in our reception for further clarification.

At the time of enrolling, families will be asked to enter their bank account or card details to set up a direct debit for payment of fees. Once you have started care, you are able to change to another form of payment if direct debit is not suitable for your family.

Fees are required to be paid in advance and kept in advance at all times. We have the following options to ensure that families can conveniently pay their accounts:

DIRECT DEBIT:

A Direct debit form will be completed when enrolling your child into Jungle Zoo's care.

- You can choose to direct debit weekly, fortnightly or monthly from your nominated bank account or debit/credit card.
- Charges will apply through our merchant FatZebra, who partner with our OWNA software.
- If your payment for direct debit is declined for any reason, you will be required to address the declined payment with Amy or our administration department immediately to arrange another form of payment⁴.

Claire and Amy are always approachable and available for discussions relating to your family's unforeseeable financial circumstances. We welcome families who may be in this situation to come and talk to us and a workable solution may be achievable for all parties.

CHANGING YOUR CHILD'S DAYS OF CARE

- When applying to increase or decrease your child's days of care, please refer to our Change of Care Form and return it to the office as soon as possible.
- Two (2) weeks written notice of intention to end care, with final day of care stated is required. The \$100 bond paid on commencement will be refunded after the final day of care has been attended and all fees are paid in full. We ask families to please use the



Cancellation of Care form when giving notice to finish care with Jungle Zoo.

 Please Note: If you choose for your child not to attend during this notice period, Government Subsidy (CCS) payments will cease from the last day your child attended the centre and full fees will be required to be paid for any sessions booked but not attended. (CCS) will not be paid for absences once a child has ceased attending care.

Your child's enrolment can be easily completed through our online portal. Claire or our admin staff, will then reach out to you, discuss our situation for your child to commence, and transfer your details to the enrolment database. Once this is done, we can complete the enrolment process.

In order for us to start off a relationship that is professional and conscientious, we are unable to allow any child to commence care without all appropriate forms completed, including emergency contact details, immunization records, any medical forms or action plans required and applicable processes for CCS and appropriate fee payments.

Immunisation

To ensure the heath of all our Jungle Zoo family, we require all children enrolling at Jungle Zoo ELC to be up to date and/or fully immunised according to legislative requirements. Please ensure that you speak to Claire or our admin staff for more details.

Upon enrolment, families are required to supply a copy of their child's updated immunisation records. An Immunisation Statement from the Australian Immunisation Register (AIR) is the only accepted evidence of your child's immunisation status. You can access this Statement from your MyGov account. Please refer to the link for further information.

Claire and the Jungle Zoo crew believe in the 'settling children and parents as fast as is reasonably practical' process. We understand the distress for parents, the uncertainty and anxiety of leaving your child. We also deeply see the beneficial effects, sense of security and belonging an Orientation can bring to both child and parents.

Therefore, at Jungle Zoo, we offer and recommend that you participate in this process, as we feel it is very important that both you and



your child have a smooth transition into the daily culture, environment and ourselves before commencing care. The orientation process may take one or more visits and is tailored to meet the individual needs of your child and family.

Confidentiality

Confidentiality is of paramount importance at Jungle Zoo. All of the information provided to us by you, such as addresses, phone numbers, and custody information, is seen and recorded only by the administration crew and the Educators directly responsible for the care of your child.

At no time will information be given out without your consent, and any individual meetings that take place between you and Amy or any of our Educators will be undertaken with the highest degree of professionalism.

Child Protection Statement

Jungle Zoo have a duty of care to protect children from risk of harm. Michelle Amy and Claire take child protection extremely seriously.

The service has policies and procedures in place to ensure legislation is followed to protect children. The Children and Young Persons Care & Protection Act 2000 requires that all Educators, Nominated

for our Crew will ensure we are all trained in the correct interpretation and procedures for detection of child protection issues.

We have security measures in place, to ensure your child is safe inside our Service⁵. An Open-Door Policy, simply means, family members can come into the Service at any time and are welcome to join in learning activities and celebrate events and special days with us.

Parents are recognised as the child's 'first teachers' and Jungle Zoo is committed to optimising your continued involvement in your children's day at our Service. Our crew encourage the involvement of

parents, carers and families in the Centre's activities and believe that this fosters an understanding, respect and awareness of the important inter-relational link between staff, children and parents.

Parents are invited to participate in the life of our Centre at a level appropriate to their personal circumstances and needs.

Participation by parents, guardians and families imparts a positive impression on your child and allows them to feel



supported as well as a **Sense of being**. There are many opportunities for involvement for our families. We understand that time can be precious for all parents, which is why we accommodate many forms of involvement to assist you and your child, and in turn benefits the centre as a whole.

We ask that you ensure your child is in attendance prior to 9.00am to allow them to settle and experience their full day's educational experience. Settling children each day with their peers and educators allows them to feel a strong Sense of belonging.

Safety and Security:

While-ever observation and supervision of children, staff and visiting family members is naturally a part of our culture (and regulatory requirements), we anticipate with a large centre and outdoor play area that there may be times we could survey an area and see a need for immediate response.

Jungle Zoo has glass windows viewing into rooms from every angle as well as CCTV cameras throughout the inside and outside of the building. These are in place to ensure the safety of all children and educators within the Service as well as families and visitors. We also have added security against (hopefully not) vandalism and break-ins.

The CCTV link is only accessed by Claire, Michelle, Amy and staff within Jungle Zoo ELC employ.

Rest assured there is no external, ONLINE access to the link at any time.

There are CCTV cameras in each of our 3 cot rooms, to enable the crew to monitor our babies and toddlers sleeping and respond immediately to an awakening child, in order to provide less disruption to other's sleeping nearby. We have cameras in each large area where there are children and Educators, providing safe supervision.

There are no CCTV camera's in the children's and adult's bathrooms or near any nappy change areas. This is to respect the privacy of our children and staff.

If you have any questions or concerns about the CCTV cameras, please speak to Claire, Michelle or Amy.

We are committed to ensuring that all your personal information that is stored on our computer system is protected. All our computer software or hardcopy files that store your personal information, including enrolment details, emergency information, medical information and other required data will have the appropriate security to ensure its safety and protection.

EMERGENCY SITUATIONS AND SAFETY AT THE SERVICE

All care is taken to avoid any emergency, but unfortunately situations may occur, and must be prepared for.

So, at Jungle Zoo, Emergency evacuations as well as simulated Lockdown procedures are regularly practiced both scheduled, and random, to enforce staff's confidence in any situation to safely care for everyone's safety.



An **evacuation** would be necessary for any situation where the children and staff are in danger inside the building, such as a fire.

A **lockdown** is activated when a local situation threatens the safety of the occupants of our building, as enforced by the local police or as determined by the responsible person in charge at the time.

- ❖ Each staff member is required to take turns in the planning, risk assessment, reporting and evaluation of the evacuation or lockdown situation on a regular basis. Rotating duties in this way ensures all staff are proficient in the exact procedures required.
- Children are taught the sounds, actions, and procedures by the Educators in a manner that will encourage awareness, not frighten.
- ❖ Procedures for evacuation are placed at every exit in the Service for the information of families and visitors. Please make yourselves aware of these evacuation procedures⁶ and if you are in attendance during the practiced drill, please ensure you follow the Educators information.

- As part of our emergency safety measures all children in attendance at the Service are noted from the signed in attendance

records. Each child is identified during a fire drill. This is

another reason why it is important to ensure that you sign your child 'IN' and 'OUT' of the Service each day.

Health and Hygiene

- Children and educators are actively encouraged to practice good personal hygiene at the service. We believe that this helps to minimise the instances of illness at the service. We also believe that if your child is ill, the best place for them is to be at home where they can recover faster.
- If your child presents at the Service with signs of illness, Amy or the responsible person at the time, may advise that they are not well enough to participate in the service's daily activities and you will be asked to make alternative arrangements until they are well or the exclusion period has ended and seek medical advice (you may be asked to provide a medical clearance letter before your child can return).
- Should your child become ill at the service, observation, documentation and first aid will commence, and you may be contacted to collect your child from the service and seek further medical advice. (Please note that Panadol is not regarded as a first response and can only be administered in emergency situations and with prior written parental consent).



- ❖ It is important that you read the service's Administering of Medication Policy⁷ carefully to know the guidelines for Educators to administer medication to your child including Panadol, prescription and non-prescription medication.
- ❖ A list of common infectious illnesses, their exclusion periods and policies and procedures related to illness and minimising the spread of infectious diseases are available from our office.

Meals and Dining

At Jungle Zoo ELC, we believe mealtimes to be a wonderful opportunity for socialising, trying new foods and experiencing different cultures. Our undercover courtyard will allow mealtimes throughout the day to be relaxing, whilst adventurous picnic style meals, allowing the children to share a time with adults and their peers. We also aim to allow children to be independent, making food selection choices and feeding themselves where appropriate. Discussions of health, nutrition and food tastes will be a big part of the format for meals time.

Educators will firstly ensure hygienic preparation of the tables as well as encourage hand washing hygiene with children, and then guide them with self- help selections of food. Educators will sit with the children and join in conversations and make mealtimes a social event.

Our qualified chef will ensure that the children are provided with a well-balanced menu that caters for all children's dietary requirements due to cultural or medical reasons. Our detailed and varied

menu will be displayed on our electronic screens daily. We are happy to share any recipes for you, especially when the children love what we have cooked.

Educators will be fully aware of children who we have been notified of having food related allergies, or specific dietary requirements. This will ensure we keep children safe and healthy, for all the Educators, and any visitors to be aware.

- Food will not be withheld from a child as a form of discipline.
- If a child chooses not to eat a meal for whatever reason they will be offered a choice of other food options or something else later-on.

Fruit and drinks will be available for snacking throughout the day, for the child who needs something more.

Parental involvement

- Please feel free to join in a mealtime, taking notice of our guide to each session.
- If you have a family recipe that you feel works well for your child, please do not hesitate to offer the recipe to our chef or Amy, to trial.
- If you would like to participate in a demonstration of cooking, please do not hesitate to offer the chance to our chef or speak to Amy. Our children and Educators would love to participate in tasting your specialty!

We work with the Dietary Guidelines of Australia to ensure a well-balanced menu for all children which will be available for all families to see.

Babies and Infants Care

Infants requiring Educators help with feeding, will enjoy their food in the nursery room.

We take your daily advice on times for babies eating, drinking, and sleeping schedules and understand the need to continue development monitoring as they quickly change these needs.





We are guided by you when your child is being introduced to solids, preferred times of eating, and taste preferences, and work with you in introducing new foods.

Infant's foods are prepared fresh daily and served according to individual development stages and dietary requirements.

For Infants requiring bottles for breast milk, or formula8: We will require you to supply bottles,

breast milk in bottles, or formula in clearly marked tins with your child's name. Boiled water is held in the fridge ready for your Infant's feed, formula is made fresh for baby, and bottles are warmed if required in bottle warmers. Excess breast milk or made-up formula after feeding baby, will be discarded after analysing if your baby is replenished.

Infants drinking from bottles can be transitioned at Jungle Zoo in the use of sippy cups. Cow's milk will be provided when they are ready.

Babies and toddlers Cot rooms and Safe Sleeping or rest



Jungle Zoo will provide your child with a busy day of play in our adventurous centre. We also value children of all ages need for sleep, rest and relaxation.

We will adhere to guidelines from Red Nose when ensuring the safety of our younger babies as we ensure their comfort during this valuable time.

We ask that children do not wear teething beads/ necklaces while at Jungle Zoo for safety reasons. They may be removed when a child is resting or sleeping.⁹

Comfortable and non-restrictive clothing is important at sleep time to promote your child's comfort at this time of the day.

Children in the older rooms will have the opportunity to rest their bodies after a busy play time.

This may consist of a rest/ sleep on a bed or a quiet story with a small group of children and educator. This time is valuable for all children to rejuvenate, ready for more fun and activity.

It is important for all school age children to have a variety of active and quieter play while with us and we will ensure that there is a wonderful balance of both for children to choose as needed.



We have included in our service:

We are aware of how busy families can be and therefore at Jungle Zoo we aim to ensure that we supply all that your child needs to enjoy their day of play and relaxation while with us throughout the day.

- 1. Nutritious, varied and enjoyable meals are included for
 - Morning Tea
 - o Lunch
 - Afternoon Tea
 - Late Supper as required
- 2. Linen for all rooms (including sheets for rest time for our older children, cots sheets for our babies) and lighter blankets for the cooler weather. The linen is laundered on site and will not be shared between children.
- 3. Nappies are provided and are regularly changed and notified, as needed.
- 4. Bibs to protect children's clothing if required.
- 5. Aprons to protect children's clothing at messy play.
- 6. On enrolment, a Jungle Zoo Hat is provided for appropriate sun safety. Additional hats can be purchased from reception.
- 7. We supply protective sunscreen cream in each room. Each day, you will be asked to ensure appropriate sunscreen is applied. The Crew will reapply all children at various intervals when needed. Jungle Zoo is a Sun Smart Service with the Cancer Council.

- 8. Antibacterial hand wash. All family members are asked to observe hand hygiene at mealtimes, after toileting, upon arrival and when leaving the service to prevent cross infection. Antibacterial wipes are made available for your use to wipe down the kiosk screens when signing in and out.
- On enrolment, a drink bottle is provided to each child. You may use this at Jungle Zoo for your child, with their name clearly marked. Additionally, we provide many opportunities for children to drink water to ensure they stay hydrated during their busy day.
- 10. Drinks such as water, cow's milk, dairy free milk, lactose free milk will be supplied throughout the day.
- 11. On enrolment at Jungle Zoo, a T-Shirt (size suitable for your child) is supplied. While this is not necessarily a uniform, if your child wishes to wear this shirt into Jungle Zoo, it may come in handy for saving your home clothing from messy play. Additional shirts can be purchased from reception.
- 12. Each child is supplied with a sun safe SPF50+ swim shirt and shorts to be worn in our waterpark.
- 13. As we do back on to mangroves, we know mosquitoes and sandflies can be particularly active in our area, especially in the late afternoon. Our Zoo crew will apply insect repellant for your child as often as sunscreen to keep your little ones comfortable.

What we suggest you might bring

Each child will have a locker at their disposal. At Jungle Zoo, our aim is to ensure that families have little to bring as we provide all that your child will need throughout the day.

You are more than welcome to pack a bag of spare clothing for your child if they need it for the day. While your child is transitioning at toileting, we would suggest, several sets of pants clearly labelled might be necessary.

If your child likes to have a secure cuddly toy¹¹, dummy or another comforter with them, this is fine to provide. Please ensure that you let us know their comfort needs, for example: to assist with separation from loved ones or when tired etc. Please try to avoid bringing toys from home if not

needed for the child's rest or comfort as these can get played with by other children and develop in unnecessary conflicts and emotional times.

We are a breastfeeding friendly service and will adhere to you and your child's direct requirements. The physical environment of our 'Zoo', is designed for children to play, learn, and develop through

Children's Clothing ready for play

exploring, discovery and creativity. Stimulating their imagination to invent and develop new skills. All this means, generally getting messy¹².



Our suggestions for appropriate clothing to enable children to maximise their day at Jungle Zoo, include:

- Jungle Zoo crew want children to be able to freely explore and play with the ability to use equipment safely, without restrictions. Clothes for children that are comfortable, able to run, jump and climb in will be the most suitable.
- We want children to be independent and empower them to toilet themselves as needed. If
 your child is toileting, clothing that allow them to develop skills to be able to become selfsufficient will help with the process. i.e. elasticised trousers, track pants rather than
 buttons, zips, belts etc.
- Children will be encouraged by educators to use aprons for messy play and art experiences to protect their clothing. Accidents and mess can always happen and therefore we encourage

you to leave their good clothing for other occasions.

- Children should be appropriately protected from the sun during outdoor play – our provision of shirts, hats & swimwear is compliant with the recommendations from the Cancer Council and Sun Safe Play.¹³
- Children's clothing should accommodate varying weather conditions. I.e. be loose and cool in summer to prevent overheating and warm enough for cold weather including outdoor play. At all times educators will monitor children to ensure they are appropriately dressed for all weather, play experiences, rest and sleep routines.
- Children should have appropriate footwear that enables them to play comfortably, run, climb and jump. Thongs, clogs or backless shoes can cause children to fall and do not allow children to use equipment safely.

- All clothing and belongings must be clearly labelled with the child's name.

Both frameworks are closely linked and follow a wonderful journey into children's learning, play and fascinations and allow principles and practices that educators can work towards to support this.

The curriculum at Jungle Zoo is developed and planned in consultation with children, educators, and families. We have an educational leader in every room at Jungle Zoo ELC, as well as an internal representative for educational mentoring and use of consulting services.

Our experience and working knowledge of the EYLF and MTOP Learning Outcomes, Principles and Practices, gives us a great basis of understanding. We are continuously learning as we observe from the children and adapt to what suits them individually.

The curriculum reflects the individual strengths and ideas of each child. All our programs across the Service are guided by our unique philosophy.

Jungle Zoo's Early Childhood curriculum is the vehicle for your child's learning and development whilst enrolled here. As mentioned previously, our program is embedded from 7.30 when we open until 5.30pm when we close, and it is most important for your child to experience the full benefit of the educational value by attending the service by at least 9.30.

We view the curriculum as everything your children will experience from our program. This includes daily routines like mealtimes, our physical environment, and our materials and equipment. It also includes time to play and discover at a pace set by the child, the interaction between and engagement of children with other children and with educators, and our partnerships and communication with families, other agencies, and the wider community.

We understand the importance of appropriate planning for children's learning. To ensure that our curriculum is of the highest standard, we employ a team of skilled and dedicated early childhood educators who are committed to challenging their own knowledge and being informed by the latest research in early childhood education.

While your child attends Jungle Zoo, our educators will keep written documentation on their learning to assist them individually and appropriately plan for your child's participation. We will consult with you as we grow this picture of your child and all recorded information about your child is available for you to peruse at any time. Educators are available, by appointment, to discuss your child's progress and they also welcome the opportunity to chat informally with you.¹⁴

In short, we follow the lead from The EYLF and MTOP with internal mentoring by our very professional Educational Leaders and consultancy from outside sources collaborate regularly within our team of Educators, to absorb and react to the children's ideas and fascinations.

We believe when children feel safe, they find confidence to explore, learn, and grow.

We want you to know all about your child's day

Communication about your child's day and ensuring that you receive as much information from us is an important priority to Jungle Zoo Crew.

With the use of 'OWNA'¹⁵ by our crew this will ensure that families can be involved in their child's day at any time.

Educators can share your child's learning, social interactions, fun and play with you on a regular basis with photos notes and stories that give you great insight into what happens throughout the day at Jungle Zoo.

This regular communication will allow for educators and families to have open discussions about their child's day when picking up their child. It is also a great tool to talk to your child about their day through the OWNA APP looking at photos and discussing with your child their play and learning.

Sustainable practices and Commitment – also what do we do with the leftovers?

At Jungle Zoo, our Educators, children and community work together to learn about and promote the sustainable use of resources and to develop and implement sustainable practices.

- Jungle Zoo implements practices such as using recycled materials in our learning environment

Written permission is required prior to any child leaving Jungle Zoo with an Educator. This authorisation can only be given by the parents or other authorised persons.

A form detailing the following must be completed and authorised.

- The reason why the child is to be taken outside the premises
- The date when the child is to be taken outside the premises
- The proposed destination
- The method of transport
- The proposed activities
- The period when the child will be away from the premises
- The number of staff members and any other responsible person who will accompany and supervise the child

Please note during any excursion the staff accompanying the children will carry a first aid kit, a mobile phone and the children's emergency contacts.

When we are planning an excursion, plenty of time is given for parents to plan, prepare and pay for the extra experience. Excursions will not be compulsory but will be planned to best benefit the curriculum for various age groups.

The management and Crew at Jungle Zoo appreciate families raising awareness of issues of concern, as this is the best way to improve our service and/or rectify mistakes.

It is advisable that confidential conversations should preferably take place in a quiet area away from children, other families and staff who are not involved. We have our director's office, where meetings can take place in a reasonable manner.

Where a complaint is preferred to remain confidential, this will be honored. However, issues cannot always be resolved in isolation and sometimes they need open discussion in a resolution focused way.

Where an educator believes, they will have to share a confidence with another person to resolve an issue, or if the nature of a complaint requires that a third party must be informed to meet legislative requirements, they will inform you of this need prior to any further discussions on the matter.

On rare occasions, Jungle Zoo Management is required (under the Child Protection laws and through our responsibility to the QLD government regulating body), to report certain issues to the QLD Regulatory Authority.

Standard steps to resolve an issue will include:

- Listening carefully to the issue at hand (either verbally or in writing)
- Interviewing all involved to obtain the facts, the obvious first step to an equitable resolution
- Looking at CCTV footage to ascertain the facts.
- Striving for a prompt resolution with reasonableness to all involved
- Advising the relevant parties of the outcome and any action taken preferably in writing
- Follow up with all involved after resolution to confirm the outcome.
- Put measures in place to prevent perpetuation in the future.
